

WWF SA WILDLIFE ADVENTURE COMPETITION: JUNE 2024 TERMS AND CONDITIONS

1. Entrants

- 1.1 The Competition is open to all residents of South Africa.
- 1.2 Directors, members, partners, agents, consultants, tenants or employees of WWF-SA, Thanda Group (Pty) Ltd t/a Thanda Safari Private Game Reserve (Reg no. 2002/004053/07), The Southern African Wildlife College NPC (Reg no. 1996/005726/08) and Zandile Ndhlovu t/a The Black Mermaid, and their immediate family members are not eligible to enter this competition.
- 1.3 This competition will not be open to persons under the age of 18.

2. Term

2.1 The competition opens on 1 June 2024 and closes at midnight on 31st June 2024.

3. The Prizes

- 3.1 The 1st Prize is a trip for 2 people to Thanda Tented Camps in KwaZulu-Natal, to participate in a Rhino Darting. The Prize includes local return flights for two people, airport transfers to and from Thanda Reserve, accommodation for two people including meals, all local drinks and additional game drives at Thanda Private Game Reserve as well as the rhino darting experience. The darting takes place over 2 nights and 3 days from Friday 2nd to the 4th August 2024. The value of this prize is R45 000.
- 3.2 The 2nd prize is a 4 day Wildlife Adventure at the Southern African Wildlife College in Hoedspruit, Limpopo, for 2 people. The prize includes local return flights for two people, airport transfers to and from the College, accommodation for 2 people including meals and all local drinks, additional game drives at the college as well as a demonstration from the Wildlife Rangers. The value of this prize is R25 000. This trip takes place from the 26th to 30th August 2024.
- 3.3 The 3rd prize includes a snorkelling experience for 4 people in the Hout Bay Area, Western Cape, with The Black Mermaid. The prize excludes accommodation and travel. The prize includes hiring of wet suits and boat hire for the day. The experience is for approximately 2 hours and is dependent on weather and water visibility.
- 3.4 In the event that the Prize specified in the Competition becomes unavailable for any reason, WWF-SA may substitute a Prize of like or equal value.

4. Entries

- 4.1 Entrants may enter and stand a chance to win a prize in the competition by making a donation to WWF South Africa of R10 000.00 or more via the online payment portal https://donate.wwf.org.za/major-donations between 1 and 30th June 2024.
- 4.2 WWF-SA takes no responsibility for any inability of an entrant to enter, complete, continue or conclude the competition due to equipment or technical malfunction, busy lines, inadvertent disconnection or otherwise.
- 4.3 By entering this competition the entrant accepts the full terms, conditions and rules of this competition and agrees to abide by these rules and any requirements and/or proceedings issued by WWF-SA in regard to the competition.

5. The Winner

- The Prizes will be awarded to **3** entrants drawn at random (overseen by an independent auditor, accountant, attorney or advocate), and the Winners will be notified by WWF-SA via email within **7 days** of the Prize draw. If the email address provided by the entrant is not valid, he/she will forfeit the Prize, and another winner will be selected on the same basis.
- 5.2 In the event that for reasons beyond the control of WWF-SA, the draw cannot take place on a date specified, WWF-SA will conduct the draw as soon as reasonably possible and notify entrants of such new draw date.
- 5.3 The Winner may be invited to be photographed, interviewed or participate in other marketing activity conducted by WWF-SA. The Winner has the right to decline such invitation.
- 5.4 The results of the competition will be verified by an independent auditor, accountant, attorney or advocate selected by WWF-SA.
- 5.5 The Winner accepts the Prize entirely at their own risk and indemnifies WWF-SA in respect of any claim for any accident, injury, or property damage that may occur in connection with the Prize to the fullest extent allowed by law.
- 5.6 The Winner will, in accepting the Prize, ensure that they and their guests abide by the terms and conditions of the venue where the Prize is provided / taken.
- 5.7 The Prize is exclusively for the Winner and is neither transferable nor exchangeable for cash or another Prize, and must be accepted by the Winner within **7 days** of being notified of winning the Prize or he/she will forfeit the Prize.
- 5.8 Where a diligent attempt to contact the Winner fails or the winner elects not to take the Prize or is unable to take the Prize for whatever reason WWF-SA reserves the right to either select another Winner or not award a Prize at all, in its sole discretion.
